

CEI Award for Young Writers

"Promoting young writers' literary works and their circulation in the CEI region"

CALL FOR APPLICATIONS 2021

Overview

The CEI Award for Young Writers is promoted by the Central European Initiative (CEI) and the Slovene Writers' Association (SWA) within the Vilenica International Literary Festival.

In the context of the extraordinary challenges caused by the COVID-19 pandemic, the CEI and the SWA have decided to revise the long-standing CEI Fellowship for Writes in Residence and provide a new concept to the initiative, launching the CEI Award for Young Writers.

The Award aims at promoting the young generation of writers and supporting the circulation of their literary works through the translation in the languages of the CEI countries. The first edition of the Award envisages the translation into Slovene¹ and the translation into another CEI language of the candidate's choice. Additional translations could be explored for the future editions of the Award.

<u>Award</u>

The CEI Award for Young Writers includes cash and in-kind prizes:

- Cash prize (5,000 EUR) to cover the full translation of the submitted work and of an excerpt into the language of one of the CEI Member States to be selected by the author and the publishing house, considering the specifics of the work. The translation shall be coordinated by the applicant in cooperation with the national publishing house supporting his/her candidature. The prize also covers the cost of copyright.
- Translation of the submitted work into Slovene language and publication by the SWA within the Vilenica CEI Collection in 2022.

¹ If the awarded author comes from Slovenia, the Award envisages the translation into English and the translation into another CEI language of the candidate's choice.

- Participation of the winner in the Vilenica International Literary Festival 2021 (most likely virtual participation) organised by the SWA.
- Cooperation and support of the CEI and the SWA to identify a publishing house for a possible publication of the translated work.

Eligible applicants

The Call for Applications is open to writers under 40 (born after 1981 – from 1 January 1982 onwards) from the CEI Member States: Albania, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, Czech Republic, Hungary, Italy, Moldova, Montenegro, North Macedonia, Poland, Romania, Serbia, Slovakia, Slovenia and Ukraine.

Applicants must have at least one work published in a book form. The submitted work for the translation must be a literary work (all genres and themes). The application must be supported by the national publisher of the work with which the author is applying.

How to apply

The application must include all the following obligatory enclosures:

- 1) A filled in registration form (here-to attached).
- 2) A biography of the applicant in English (max. 1800 characters without spaces).
- 3) Copy of a valid ID or passport with the visible date and place of birth, and the citizenship of the applicant.
- 4) A bibliography of the applicant in English (max. 3600 characters without spaces).
- 5) Scan of original signed letter of recommendation in English written by the applicant's national publisher that includes the presentation of the applicant and the proposed work, written by the applicant and to be translated into two CEI Member States' languages (4000 8000 characters without spaces).
- 6) An excerpt from the proposed work in the original CEI Member State language and in English (max.100 lines of POETRY or max. 7000-9000 characters with spaces of PROSE TEXT).
- 7) Incomplete entries will not be considered.

Deadline

Applications shall be submitted by 24 June 2021 (23:59 CEST).

Evaluation procedure and awarding

- 1) The international committee will consider entries sent on or before 24 June 2021
- 2) Entries will be evaluated according to the following criterion: 30% (3 points) for the bibliography, 50% (5 points) for the letter of recommendation with presentation of the applicant and of the proposed work that will be translated and 20% (2 points) for the excerpt from the same work, in original CEI Member State language and translated into English.
- 3) All the candidates will be notified of the decision of the committee by 31 July 2021.
- 4) The awarding ceremony will take place on the first day of Vilenica Festival (7-12 September 2021). The winner and the national publishing house must provide a sample translation of an excerpt from the submitted work by 30 November 2021 and a written report by May 2022. The translation costs must be covered from the awarded financial means.

Organisers

The Slovene Writers' Association promotes creative freedom, acts as advocate to improve the status of Slovene literature and writers, and brings together writers from the entire Slovene cultural space, regardless of the borders. Always critical and creative, the association has helped make significant changes in the Slovene social and cultural space and life. It was very active during Slovenia's quest for independence and the formation of the young country. The Vilenica International Literary Festival, a gathering of poets, prose writers, playwrights and essayists, but also translators, publishers, editors and critics from Central Europe and beyond is organised by the Slovene Writers' Association in collaboration with the Cultural Society Vilenica from Sežana. Since the first Vilenica international festival in 1986, the climax of the event has been the presentation of the Vilenica International Literary Prize, awarded by the Slovene Writers' Association to a Central European author for outstanding achievements in the field of literature and essay writing.
